

INVESTMENT OBJECTIVE

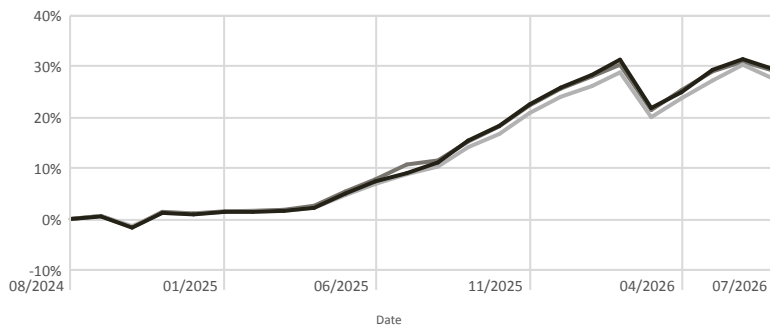
The All Weather FR Bond Fund aims to generate returns above the FTSE JSE All Bond Index ("ALBI") over time, utilizing active bond management combined with strategies which aim to reduce risk.

INVESTMENT POLICY

In order to achieve this objective, the investments normally to be included in the portfolio will comprise a combination of assets in liquid form and a combination of bonds and interest-bearing securities, including loan stock, debentures, debenture bonds, money market instruments, notes corporate debt and non-equity securities. The portfolio invests predominantly in domestic bonds. The portfolio may also invest in participatory interests or any other form of participation in portfolios of collective investment schemes or other similar collective investment schemes as the Act may allow from time to time, and which are consistent with the portfolio's investment policy. Foreign schemes can only be included in the portfolio if their regulatory environment provides investor protection that the manager and trustee consider equal to South Africa's standards. The portfolio may from time to time invest in listed and unlisted financial instruments, in accordance with the provisions of the Act.

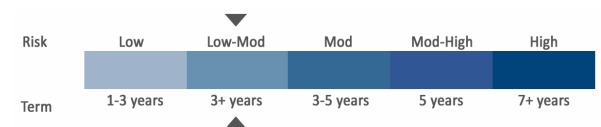

- The expected potential long-term investment returns are lower but less volatile over the medium to long term than higher risk portfolios.

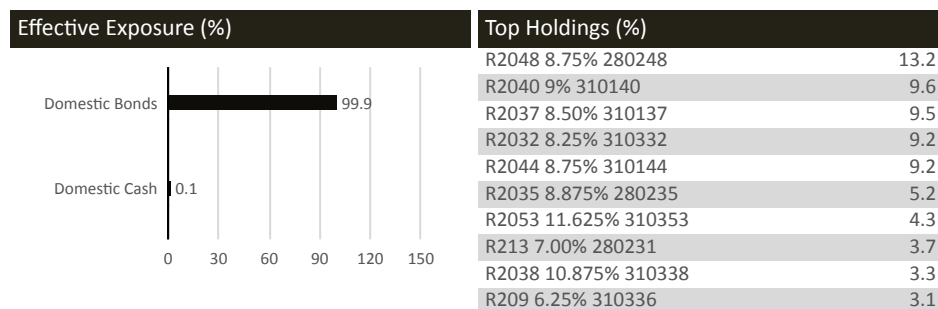
